First of all Shri Ashok Kumar Aggarwal, Secretary General, Yoga Federation of India, while extending welcome to the members present in the meeting, requested Shri K.C. Sharma, IAS (Retd.) President, Yoga Federation of India, to preside over the meeting.

Shri K.C. Sharma, President, Yoga Federation of India accepted the request and extended hearty welcome to the members of Yoga Federation of India and officials of different State Yoga Associations. He also conveyed his sincere thanks to Shri S.S. Gill, IAS (Retd.), President, Punjab Yoga Association, Shri Tikshan Sood, Chairman, Organizing Committee, 37th National Yoga Championship, Dr. C.K. Mishra, Secretary, Punjab Yoga Association, Shri Puneet Khullar, Secretary, District Yoga Association, Hoshiarpur, District Administration, Hoshiarpur & other members of Organizing Committee for taking the arduous task of organizing 37th National Yoga Championship at Hoshiarpur (Punjab). He asked the Secretary General to proceed further as per the agenda of the meeting.

The Secretary General, Yoga Federation of India, expressed his gratitude to the Members of Organizing Committee for making excellent arrangements for the successful organization of 37th National Yoga Championship.

Following points were taken according to the agenda of the meeting.

1. Confirmation of the minutes of the previous Annual General Meeting of Yoga Federation of India held on 29th November, 2011 at Sree Kshetra Dharmastala, Karnataka.

The minutes of Annual General Meeting of Yoga Federation of India held on 29th November, 2011 at Sree Kshetra Dharmastala, Karnataka were considered. Dr. S.P. Shokeen of Delhi proposed and Dr. Asit Aich of West Bengal seconded and the house unanimously confirmed the minutes.

2. Annual report of Yoga Federation of India for the session 2011-12.

The Secretary General, Yoga Federation of India, while presenting the annual report of Yoga Federation of India, informed the house that 36th National Yoga Championship was successfully organized under the patronage of Rajarshi Dr. D. Veerendra Heggade by Shantivana Trust (R) Shri Kshetra Dharamsthala and Karanataka State Amateur Yoga Sports

Association from 29th November, 2011 to 03rd December, 2011 at Shri Kshetra Dharamsthala (Karnataka). The Championship was inaugurated by Padam Shri B.K.S. Iyengar, and Shri Oscar Fernades, Member of Rajya Sabha was the Chief Guest of the Prizes Distribution Function. The Yoga Federation of India contributed Rs.50,000/- to the Shantivana Trust (R) Shri Kshetra Dharamsthala for the organization of 36th National Yoga Championship at Shri Kshetra Dharamsthala, Karnataka.

He also informed that the 2nd Asian Yoga Championship was successfully organized by Yoga Federation of India, hosted by Yoga Association of Andhra Pradesh from 31st August to 02nd September, 2012 at Sports Authority of Andhra Pradesh Indore Stadium, Saroornagar, Hyderabad (Andhra Pradesh) India, in which 9 countries namely Hongkong, Thailand, Iran, Afghanistan, Sri Lanka, Singapore, China, Vietnam and host India have participated. The 30 members team of Yoga Federation of India won the overall general championship of 2nd Asian Yoga Championship.

It was also informed by Secretary General, Yoga Federation of India that 10 members team of Yoga Federation of India participated in World Yoga Super Cup-2011 held from December 17 to 18, 2011 at Montevideo, Uruguay. The Indian team won the overall World Yoga Super Cup-2011 by winning 13 Gold Medals, 11 Silver Medals & 9 Bronze Medals. The house appreciated the achievements of the Yoga Federation of India in the Asian and World Yoga Championship.

Dr. P.K. Mitra, of Jharkhand proposed, Shri Sher Singh of Rajasthan and Shri Raman Sharma of Himachal Pradesh seconded and the house unanimously approved the annual report for the session 2011-12.

3 Allotment of 38th National Yoga Championship.

The Jharkhand, Maharashtra and Madhya Pradesh State Yoga Associations offered to host 38th National Yoga Championship in their respective states. After discussion, the house unanimously decided to allot the 38th National Yoga Championship to the Jharkhand Yoga Association, to be hosted at Ranchi (Jharkhand). Dr. P.K. Mitra, Secretary, Jharkhand Yoga Association assured the house to provide all type of facilities to the Yoga participants during 38th National Yoga Championship. It was also decided that Jharkhand Yoga Association will invite the Secretary General, Yoga Federation of India to visit Ranchi (Jharkhand) to look into the venue and other arrangements of 38th National Yoga Championship. The tentative dates for organization of 38th National Yoga Championship have been suggested from 26th to 30th October, 2013 or 16th to 20th November, 2013 at Ranchi (Jharkhand).

4. Approval of Audited Income & Expenditure Statement of Accounts for the session 2011-12.

Shri O.P. Malick, Treasurer, Yoga Federation of India, presented the audited income & expenditure statement of accounts of Yoga Federation of India for the session 2011-12. Shri Deo Dutta, Working President, Yoga Federation of India proposed, Shri J. Mahohar of Andhra Pradesh, Shri Mohinder Sharma of Himachal Pradesh and Shri Navin Acharya of Goa

seconded and the house approved the audited income & expenditure statement of accounts of Yoga Federation of India for the session 2011-12.

5. Any other point to be discussed with the permission of chair.

- i. Shri G.N. Krishnamurthy, Secretary, Karanataka State Amateur Yoga Sports Association requested that the copy of the bye-laws of Yoga Federation of India may be given to him. The Secretary General, Yoga Federation of India ensured that the same will be sent to him.
- ii. The Secretary General, Yoga Federation of India proposed to enhance the Entry Fee and the Annual Affiliation Fee. Shri K.C. Sharma, President, Yoga Federation of India proposed to enhance the Annual Affiliation Fee from Rs.3000/- to Rs.5000/- w.e.f. the next session i.e. 2013-14, Entry Fee should remain the same i.e. Rs.100/- each event each competitor for National Yoga Championship. It was also proposed that the entry fee for State Yoga Championship should Rs.100/- per each event and the Annual Affiliation Fee District Yoga Associations with their respective State Yoga Association should be Rs.1000/- per unit. The house unanimously accepted the proposal.
- iii. The Secretary General, Yoga Federation of India informed the house that most of the states are not sending their Entry Performa well in time because of which the federation has to face lot of difficulties in conducting National Yoga Championship in time. Therefore, the State Secretaries should mail the copy of entry proforma, duly filled to the Secretary General, Yoga Federation of India and to the host of National Yoga Championship by the last date of entry, failing which the State Secretaries have to pay double entry fee i.e. Rs.200/- per competitor.
- iv. The Secretary General, Yoga Federation of India also informed that some of the states are not bringing Medical Fitness Certificates and Risk Certificates of their players during the championship, in spite of repeated reminders from the federation. In this connection the Secretary General, Yoga Federation of India suggested that the states/players failing to submit the medical fitness certificates and risk certificates will be imposed financial penalty of Rs.100/- for each defaulter competitor.
- v. The Secretary General, Yoga Federation of India requested the State Yoga Association to send full names and addresses of their President and Secretary with their e-mail and mobile no. alongwith copy of registration certificate (Regd. Under the Societies Registration Act XXI of 1860), affiliation certificate with their State Olympic Association, and also names & addresses of affiliated District Units by 30th March, 2013 positively.
- vi The Secretary General, Yoga Federation of India requested the office bearers of Yoga Federation of India to pay their contribution of Rs.5000/- (once in a term of four years) as their membership by the Bank Draft drawn in favour of Yoga Federation of India payable at State Bank of India, Panchkula.
- Vii He also requested that the State Yoga Associations must conduct their State Yoga Championships at least 1½ month before the National Yoga Championship, invite Zonal Secretaries of their respective zones to witness the State Yoga Championship and send the report to the Secretary General, Yoga Federation of India. Henceforth the Zonal Secretaries are requested to look after the activities of the states of their respective zones as detail below:-

6. Election of Office Bearers and Executive Members of Yoga Federation of India.

It was informed by Secretary General, Yoga Federation of India that four years term of present house of Yoga Federation of India has been over, and therefore a new house has to be elected for the term of next four years i.e. 2013-2017. He suggested that the present house has to be dissolved and proposed the name of Shri K.C. Sharma to preside over the election meeting of Yoga Federation of India. The house unanimously approved the proposal. Shri K.C. Sharma accepted the same and asked the house to proceed further.

Shri Deo Dutta of Uttar Pradesh, Dr. P.K. Mitra of Jharkhand, Dr. Asit Aich of West Bengal and Shri Navin Acharya of Goa proposed the names of Shri K.C. Sharma to be re-elected as President and Shri Ashok Kumar Aggarwal as Secretary General, Yoga Federation of India and authorized them to nominate the other Office Bearers and Executive Members of Yoga Federation of India, seconded by Shri D.C. Sharma of Chandigarh, Acharya Mohinder Sharma of Himachal Pradesh, Shri N.Ramalingam of Tamil Nadu and Shri Anil Gupta of Jammu & Kashmir, and the house unanimously reelected Shri K.C. Sharma as President and Shri Ashok Kumar Aggarwal as Secretary General, Yoga Federation of India and authorized them to nominate their team for a term of office bearer and executive members of Yoga Federation of India for next four years i.e. 2013-2017.
