First of all Shri Yash Parashar, Zonal Secretary (North Zone), Yoga Federation of India while welcoming Shri Ramesh Sharma, Advocate, Supreme Court of India and Punjab & Haryana High Court, Chandigarh, the Returning Officer of the Election Meeting of Yoga Federation of India and Presidents / Secretaries from State Yoga Associations, requested Shri Ashok Kumar Aggarwal, President, Yoga Federation of India to preside over the meeting of Yoga Federation of India, seconded by Shri Raman Kumar, General Secretary, Himachal Pradesh Yoga Association and Organizing Secretary, YFI.

Shri Ashok Kumar Aggarwal accepted the request and chaired the meeting of Yoga Federation of India. He extended warm welcome to Advocate Shri Ramesh Sharma and expressed his gratitude to him for accepting the request to be the Returning Officer of the Election Meeting of Yoga Federation of India. He also extended welcome to the members present in the meeting.

Following points were discussed in the meeting.

1. <u>Confirmation of minutes of Virtual Special Meeting of Yoga Federation of India held on 05.01.2021.</u>

It was informed by the President, Yoga Federation of India that the minutes of Virtual Special Meeting of Yoga Federation of India held on 05.01.2021 were circulated. Shri Chandrakant S. Pangare (Maharashtra) proposed and Shri Raman Kumar (Himachal Pradesh) Seconded and the minutes of the meeting of 05.01.2021 were unanimously confirmed by the house.

2. <u>45th Sub-Junior, Junior & Senior National Yogasana Sports Championship online-live</u> on 15th, 16th, 17th, 23rd, 24th, 30th & 31st January, 2021.

It was informed by the President, YFI that the 45th Sub-Junior, Junior & Senior National Yogasana Sports Championship was inaugurated on 15th January, 2021 in which Dr. Anil Agarwal, Member Parliament was the Guest of honor. He further informed that in this championship 1235 Yoga Players (614 Males and 621 Females) and 110 National Yoga Referees from 25 States / Union Territories including Yoga team from All India Police Sports Control Board are participating. The Valedictory Function of the Championship will be held on 31st January, 2021 at 03:00 PM.

3. National Yoga Referee's Diploma Examination online on 14th March, 2021.

The President, YFI informed that the Yoga Federation of India has decided to conduct National Yoga Referee's Diploma Examination online on 14th March, 2021, in which beside the candidates who have not qualified the National Yoga Referee's Diploma Examination held on 11th October, 2020, the application from new candidates will also be called.

4. <u>Election of the new house of Yoga Federation of India for the session i.e. 2021-2025 for a term of next four years.</u>

It was informed by the President, YFI that the present term of the house i.e. 2017-2021 is going to expire on 27.01.2021, therefore, a new team of house for a term of next four years i.e. 2021-2025 has to be elected, hence the present house has to be dissolved and new house will be elected under the supervision of Returning Officer, Advocate Ramesh Sharma. He requested Advocate Ramesh Sharma to preside over the Election meeting of Yoga Federation of India.

Advocate Ramesh Sharma, accepted the request and presided over the meeting as the Returning Officer of Yoga Federation of India. He requested the house to proceed.

For the post of President, Dr. Abhinav Joshi, General Secretary, Yoga Sport Association of Rajasthan requested Shri Ashok Kumar Aggarwal, to continue as the President, Yoga Federation of India for the next term also but Shri Ashok Kumar Aggarwal denied to accept the request on the ground that as per National Sports Development Code of India, 2011 of Ministry of Youth Affairs and Sports Govt. of India, any person should not

continue as the Office Bearers of any National Sports Federation after attaining the age of 70 years. As he has crossed the age of 70 years, therefore, abiding the NSDC, 2011 of Ministry of Youth Affairs and Sports Govt. of India, he would not prefer to continue as the President, Yoga Federation of India.

Shri Sanjay Kumar Jha suggested that as NSDC-2011 does not apply on the Yoga Federation of India till the recognition is given by Ministry of Youth and Sports, Govt. of India therefore, he suggested that Shri Ashok Kumar Aggarwal should continue as President of Yoga Federation of India till the recognition is given to the Federation but Shri Ashok Kumar Aggarwal again denied the request of Shri Sanjay Kumar Jha.

Keeping in view the dynamic leadership and contribution of Shri Ashok Kumar Aggarwal for the last 45 years in raising the Yoga Federation of India to new heights, it was proposed by Shri Yash Parashar, General Secretary, Uttar Pradesh Yoga Association that Shri Ashok Kumar Aggarwal must continue with the Yoga Federation of India as Life Time Chairman, as there is provision of the post of Life Time Chairman in the constitution of Yoga Federation of India. He further proposed the name of Smt. Indu Aggarwal as the President of Yoga Federation of India. Shri Chandrakant Pangare seconded the proposal of Shri Yash Parashar. Further, Shri M.P. Singh, President, Yoga Sports Association Madhya Pradesh, Shri Jatin Solanki, General Secretary, Maharashtra Yoga Association, Dr. Rajiv Uppal, General Secretary, Chandigarh Yoga Association, Shri Gautam Sinha, General Secretary, West Bengal Yoga Association, Shri Gangadharappa, President, Karnataka State Amateur Yoga Sports Association, Shri Prabir Karmakar, President, Jharkhand Yoga Association, Shri K. Prabhu (Karnataka), Shri Manohar Jala, General Secretary, Telangana Yoga Association, Shri S. Sreenivasulu Naidu, Working President, Yoga Association of Andhra Pradesh, Shri M.K. Virmani, Chairman, Chandigarh Yoga Association supported the proposal of Shri Yash Parashar and the house unanimously nominated Shri Ashok Kumar Aggarwal as the Life Time Chairman and Smt. Indu Aggarwal as the President of Yoga Federation of India. Adv. B. Balachandran, President, Yoga Association of Kerala while supporting the decision of the house also informed that the Hon'ble Chief Minister of Kerala has extended his cooperation and best wishes to Shri Ashok Kumar Aggarwal.

Further Shri Ashok Kumar Aggarwal proposed that Shri Sanjay Kumar Jha, General Secretary, Jharkhand Yoga Association should be again nominated as Secretary General, Yoga Federation of India. For the post of Treasurer, Yoga Federation of India as Shri O.P. Malick who has been the Treasurer in the previous house has also crossed the age of 70 years therefore, he suggested the name of Shri Raman Kumar, General Secretary, Himachal Pradesh Yoga Association to be the new Treasurer of Yoga Federation of India. For the post of Organizing Secretary, he proposed the name of Shri Yash Parashar, General Secretary, Uttar Pradesh Yoga Association. He also suggested that the house may authorize the President, YFI to nominate the remaining posts afterward. The house gave its unanimous approval for the same.

Adv. Ramesh Sharma, the Returning Officer, before announcing the election result of the Office Bearers of Yoga Federation of India, once again asked the members present in the house to give their opinion if any, so that there is no confusion in the unanimity of the decision of the house. As no member raised any objection therefore, he announced the decision of the house as 'Shri Ashok Kumar Aggarwal will be the Life Time Chairman, Smt. Indu Aggarwal, the President, Shri Sanjay Kumar Jha the Secretary General, Shri Raman Kumar, the Treasurer and Shri Yash Parashar, the Organizing Secretary of the Yoga Federation of India for the session 2021-2025'. He congratulated the members nominated as the new Office Bearers of Yoga Federation of India and appreciated the house for peaceful election and solidarity exhibited by the Officials of the State Yoga Associations.

As there was no other business to transact, the meeting came to end with vote of thanks to the chair.
