First of all Shri Raman Kumar, Treasurer, Yoga Federation of India, extended hearty welcome to the Office Bearers, Yoga Federation of India & the Presidents / Secretaries, State/UT Yoga Associations present in the meeting and requested Shri Sanjay Kumar Jha, Secretary General, Yoga Federation of India to request Smt. Indu Aggarwal, President, YFI to chair the meeting. Shri Sanjay Jha, Secretary General, Yoga Federation of India while extending welcome to Shri Ashok Kumar Aggarwal, Lifetime Chairman, YFI and President, AYF, office Bearers, Yoga Federation of India and all the Presidents / Secretaries, State / UT Yoga Associations conveyed his thanks to all of them for joining the meeting and requested Smt. Indu Aggarwal, President, YFI to preside over the meeting, which was accepted by her.

The president, YFI while extending hearty welcome to all the members present in the meeting conveyed her thanks to the Officer Bearers, YFI and Presidents / Secretaries State / UT Yoga Associations for extending their whole hearted support to make the activities of Yoga Federation of India successful and congratulated the State Presidents/ Secretaries for organizing their respective State Yogasana Sports Championship with all fervour. She conveyed her gratitude to the Presidents/Secretaries, District Yoga Associations affiliated with their respective State Yoga Associations for conducting their District Yogasana Sports Championships in a well organized way.

## Following points were discussed as per agenda of the meeting.

# 1. 47<sup>th</sup> Sub-junior & Junior National Yogasana Sports Championship from October 28-31, 2022 at Dass and Brown World School, Ferozepur City (Punjab).

It was informed by the President, YFI that due to clash in the dates of 47<sup>th</sup> Sub-junior & Junior National Yogasana Sports Championship with the National Games the dates of 47<sup>th</sup> Sub-junior & Junior National Yogasana Sports Championship has been rescheduled and now will be held from 28<sup>th</sup> to 31<sup>st</sup> October, 2022. She also informed that although the last date of entry for this championship was informed to be 10<sup>th</sup> September, 2022 but on the request of some members of the house, it was extended to 30<sup>th</sup> September, 2022 and requested all the State Presidents/Secretaries to send the entry fee for the said championship before the last date of entry i.e. 30<sup>th</sup> September, 2022 positively along with the information regarding their journey schedule, number of players, officials, referees (male & female separately) to facilitate the host to make their transportation and lodging & boarding arrangements.

The President, YFI requested the State Presidents / Secretaries to must get the players who have participated in their State/UT Yogasana Sports Championship registered with the YFI as soon as the State / UT Yogasana Sports Championship is concluded as per Google Forms Link: —

(https://docs.google.com/forms/d/e/1FAlpQLSe6DWI-0UG\_b6eOSjSj\_gjcli2aNkc4OqluDQ9A1MH1hW4JRg/viewform) alongwith the player registration fee of Rs. 50/- per player (only this year), so that their data can be uploaded on the website of YFI and their I-Card can be prepared in time. Nobody will be allowed to participate in the ensuing Nationals without Player Registration Card.

It was further requested by her that all the State Presidents/Secretaries must instruct the players of their State / UT selected for participation in 47<sup>th</sup> Sub-junior & Junior National Yogasana Sports Championship to practice the Yogasana protocol already shared with them so that a Mass Yoga Demonstration can be presented during the prize distribution function of said national on 31<sup>st</sup> October, 2022.

## 2. 47<sup>th</sup> Senior National Yogasana Sports Championship by MIT-Pune (Maharashtra) and Maharashtra Yoga Association.

It was informed by the President, YFI that the All India Police Sports Control Board is conducting their Volleyball Cluster (National Yoga Meet) from 10<sup>th</sup> to 15<sup>th</sup> December, 2022 at Punjab, therefore there is clash of dates i.e. December 07-11, 2022, fixed for 47<sup>th</sup> Senior National Yogasana Sports Championship. The new dates of 47<sup>th</sup> Senior National Yogasana Sports Championship will be fixed & informed by the host very soon.

## 3. National Yoga Referees Diploma Examination Grade (A, B & C).

The date for online National Yoga Referees Diploma Examination Grade (A, B & C) was earlier fixed on 18<sup>th</sup> September, 2022 but still some of the state secretaries have not forwarded the names of candidates for the said examination, therefore, its dates has been rescheduled and will now be held on 25<sup>th</sup> September, 2022. She requested the Presidents/Secretaries State Yoga Associations to forward the names of the candidates' for the said National Yoga Referee's Diploma Examination earliest possible so that the application form can be shared with the candidates to get their complete particulars and further instructions.

## 4. 6<sup>th</sup> Federation Yogasana Sports Cup.

The President, YFI informed the house that 6<sup>th</sup> Federation Yogasana Sports Cup (Online Live) is going to be held on 03<sup>rd</sup>, 04<sup>th</sup>, 10<sup>th</sup> & 11<sup>th</sup> September, 2022 but still the entry fee of maximum states have not been received by the federation, therefore she requested the State Presidents/Secretaries to send the entry fee of the said Federation Cup immediately, so that the yoga players may not be deprived of their participation in the said championship.

Keeping in view less number of entries in the Rhythmic Pair (Male & Female) Yogasana Competition. It was decided by the house that the Rhythmic Pair Yogasana Competition & Artistic Pair Yogasana Competition may be conducted combined for male & female players for this year and also for future Federation Yogasana Sports Cup.

She requested all the State Presidents/Secretaries to grace the valedictory function of 6<sup>th</sup> Federation Yogasana Sports Cup on 11<sup>th</sup> September, 2022 at 03:30 PM with their benign presence.

## 5. 7<sup>th</sup> National Yoga Referee's Refresher Course.

It was proposed by the President, YFI that 7<sup>th</sup> National Yoga Referee's Refresher Course may be conducted on October 1 & 2, 2022 in which beside other National Yoga Referees atleast those National Yoga Referees who will be attending the 47<sup>th</sup> Sub-junior & Junior National Yogasana Sports Championship and 47<sup>th</sup> Senior National Yogasana Sports Championship must attend the said National Yoga Referee's Refresher Course, so that they may be apprised of the latest rules & regulations of the National Yogasana Sports Championship, which was approved by the house. She further requested to send the names of National Yoga Referees of their states earliest possible, so that their group can be prepared and instructions may be informed to them in time.

### **6.** State Yogasana Sports Championship.

It was informed by the President, YFI that although maximum States Yoga Associations have already concluded their State Yogasana Sports Championship yet some of the State Yoga Associations have still not informed the dates of their State Yogasana Sports Championship. Therefore, she requested all the remaining states who have still not conducted their State Yogasana Sports Championship to complete the same by 20<sup>th</sup> of September, 2022 positively,

so that their entry fee can be sent by their State Yoga Associations before 30<sup>th</sup> of September, 2022 positively otherwise late fee of Rs.200/- extra i.e. Rs. 500/- per competitor will be charged upto 10<sup>th</sup> October, 2022 and after that no entry fee will be accepted by the federation. She further requested the states who have already completed their State Yogasana Sports Championship to send the Entry Performa alongwith entry fee for 47<sup>th</sup> Sub-junior & Junior National Yogasana Sports Championship immediately.

7. It was informed by the President, YFI that some rejoinder / amendments are required from time to time / urgently basis in the Hon'ble Delhi High Court (Case No : W.P.(C)-20/2021 of Hon'ble Delhi High Court) for court case of Yoga Federation of India for that somebody should be authorised to present in the Hon'ble Delhi High Court. In this connection the house passed a resolution as given below: —

#### Resolution: -

"The house passed a resolution in the General Body Meeting of Yoga Federation of India held on 01.09.2022 to supersede all the decision taken by the then President, Yoga Federation of India, Shri Ashok Kumar Aggarwal regarding the authorization / nomination given to any person in connection with the filing a Special Leave Petition / Public Interest Litigation / Writ / Appeal / Rejoinder / LPA for exclaiming / declaring the Court Case of Yoga Federation of India (Case No: W.P.(C)-20/2021 of Hon'ble Delhi High Court).

The house authorised Smt. Indu Aggarwal, President, Yoga Federation of India, R/o Flat No. 501, GH-93, Sector-20, Panchkula (Haryana) (elected unanimously in the Annual General Meeting of Yoga Federation of India held on 19.01.2021) to present herself or authorise / nominate any member of the Yoga Federation of India to represent Yoga Federation of India before the Hon'ble Delhi High Court for filing a Special Leave Petition / Public Interest Litigation / Writ / Appeal / LPA for exclaiming / declaring / enacting Yoga / Yogasana as Sport / game by Ministry of Youth Affairs and Sports, Government of India. This letter/certificate shall be considered as authority letter/ Power of Attorney for Hon'ble Delhi High Court purposes (Case No: W.P.(C)-20/2021 of Hon'ble Delhi High Court)."

As there was no other business to transact, the meeting came to end with vote of thanks to the chair.
