Also Acharya Mahender Sharma, President, Himachal Yoga Association extended welcome to the members present in the meeting and conveyed his thanks to all for coming to Una (Himachal Pradesh).

Shri Raman Kumar, Treasurer, Yoga Federation of India requested Mrs. Indu Aggarwal, President, Yoga Federation of India to preside over the Annual General Meeting of the Yoga Federation of India.

While accepting the request Smt. Indu Aggarwal, President, YFI greeted the members present in the meeting and conveyed her thanks to the Officer Bearers, YFI, Presidents / Secretaries State / UT Yoga Associations, National Yoga Referees for their benign presence at the occasion and Yoga Players from 32 states of India for their participation in the 49th Sub-Junior & Junior National Yoga Sports Championship at Una (Himachal Pradesh). She conveyed her thanks to the office bearers of Himachal Yoga Association particularly their President, Acharya Mahender Sharma, & General Secretary, Shri Raman Kumar and their entire dedicated team for the organization of 49th Sub-Junior & Junior National Yoga Sports Championship from 24th to 27th October, 2024 at Una (Himachal Pradesh).

On behalf of YFI, the President also greeted Adv. Amit Mehta and conveyed her thanks to him for considering the request of Yoga Federation of India to be the observer of election meeting of Yoga Federation of India. Also she conveyed her thanks to Shri Ashok Kumar Aggarwal, President, Asian Yoga Federation for his presence as the observer of YFI meeting's proceedings.

Following points were discussed as per agenda of the meeting.

1. Confirmation of the minutes of the previous General Body Meeting of Yoga Federation of India held on 19th March, 2024 at Hooghly, (West Bengal) and virtual meeting of Yoga Federation of India held on 04th September, 2024 : –

It was informed by the President, YFI that the last General Body Meeting of YFI was held on 19.03.2024 at Hooghly (West Bengal) at the occasion of 48th Senior National Yoga Sports Championship. Also a virtual meeting of YFI was held on 4th September, 2024 to finalize the name of returning officer for the election meeting of Yoga Federation of India. She further informed that the minutes of the said meetings were circulated earlier to all the members of Yoga Federation of India.

Yogiraj N. Ramanlingan, Vice President, YFI & General Secretary, Tamil Nadu Yogasana Sports Association proposed and Shri G.N. Krishnamurthy, President, Karnataka State Amature Yoga Sports Association seconded and the house unanimously approved the minutes of General Body Meeting of YFI held dated 19.03.2024 and 04.09.2024.

2. Annual report of Yoga Federation of India for the Session 2023-24 : –

The President, YFI informed that the annual report of Yoga Federation of India for the session 2023-24 was to be presented by Shri Sanjay Jha, Secretary General, Yoga Federation of India but due to some unavoidable circumstances, he was unable to attend the said meeting at Una (H.P.).

Therefore, while presenting the report of Yoga Federation of India, she informed the house that during the period 2023-24, the Yoga Federation of India organized: –

(i) 8th Federation Yoga Sports Cup Online Live – on 08th, 09th, 15th & 16th June, 2024.

8th Federation Yoga Sports Cup Online Live – on 08th, 09th, 15th & 16th June, 2024. Total 547 players (285 female & 262 male) and 92 National Yoga Referee from all states of India participated.

West Bengal Yoga Team won the Overall General Championship followed by Maharashtra State Yoga Team winning 1st Runner's up position and Assam Yoga Team winning 2nd Runner's up position.

(ii) Yoga Referee's Diploma Examination and National Yoga Referee's Up-gradation Examination – 2023 – Online on 17th September, 2023

The federation conducted online National Yoga Referees Diploma & National Yoga Referee Up-gradation Examination on 17th September, 2023. Total 175 candidates cleared the exam of Grade A (9 Referees), Grade B (13 Referees) & Grade C (153 Referees) and were awarded National Yoga Referee Diploma Certificates during virtual National Yoga Referee Diploma Presentation Ceremony held on 17th September, 2023.

(iii) 8th National Yoga Referees' Refresher Course on 07th to 08th October, 2023

8th National Yoga Referees' Refresher Course live – online was organized on 07th & 08th October, 2023. Total 194 National Yoga Referee from all states of India participated and updated their technical knowledge with this refresher course.

(iv) Workshop for National Yoga Referees attending 48th Sub-Junior & Junior National Yoga Sports Championship from 30th October to 04th November, 2023

Workshop for National Yoga Referees attending 48th Sub-Junior & Junior National Yogasana Sports Championship was held from 30th October to 04th November, 2023. Total 115 National Yoga Referees attended the workshop.

(v) 48th Sub-Junior & Junior National Yogasana Sports Championship from 23rd to 26th November, 2023 at Guwahati (Assam)

The 48th Sub-Junior & Junior National Yogasana Sports Championship was concluded successfully on 26th November, 2023 at DTRP Indoor Stadium, Guwahati (Assam) in which 677 Yoga Players (312 Males, 331 Females & 34 Professional Women) from 30 States/UTs of India participated in the five age groups of Sub-Junior & Junior Yogasana and two age groups of Professional Yogasana Competition (Females). 173 male & female Competitors exhibited their performances in Artistic Solo, Artistic Pair, Rhythmic and Free Flow Yogasana Sports Competition and 151 National Yoga Referees of Yoga Federation of India attended the championship.

West Bengal Yoga Team won the Overall General Championship followed by Haryana State Yoga Team winning 1st Runner's up position and Maharashtra Yoga Team winning 2nd Runner's up position.

A Mass Yogasana Demonstration of all the yoga players who had participated in the 48th Sub-Junior & Junior National Yogasana Sports Championship was held in the morning of 26th November, 2023, which was highly appreciated by the guests present at the occasion.

(vi) Workshop for National Yoga Referees attending 48th Senior National Yoga Sports Championship from 21st to 23rd February, 2024

Workshop for National Yoga Referees attending 48th Senior National Yoga Sports Championship was held from 21st to 23rd February, 2024. Total 128 National Yoga Referees attended the workshop.

(vii) Yoga Referee's Diploma Examination and National Yoga Referee's Up-gradation Examination – 2024 – Online on 03rd March, 2024

The federation conducted online National Yoga Referees Diploma & National Yoga Referee Up-gradation Examination on **03rd March, 2024**. Total 68 candidates cleared the exam of Grade A, B & C and were awarded National Yoga Referee Diploma Certificates during virtual National Yoga Referee Diploma Presentation Ceremony held on 03rd March, 2024.

(viii) Yoga Workshop for National Yoga Referees attending 48th Senior National Yoga Sports Championship on 10th March, 2024

Yoga workshop for National Yoga Referees attending 48th Senior National Yoga Sports Championship was held on 10th March, 2024 for coordinators, stage marshals, Judges & referees assigned the jobs of Time, Announcement, Caller and Documentation.

(ix) 48th Senior National Yoga Sports Championship held from 19th to 23rd March, 2024 at Hooghly (West Bengal)

The 48th Senior National Yoga Sports Championship was concluded successfully on 23rd March, 2024 at H.M. Education Centre, Hooghly (West Bengal) in which 657 Yoga Players (341 Males, 316 Females & 26 Professional Men) from 29 States/UTs of India participated in the six age groups of Senior Yogasana and two age groups of Professional Yogasana Competition (Males). 167 male & female Competitors exhibited their performances in

Artistic Solo, Artistic Pair, Rhythmic and Free Flow Yoga Sports Competition and 129 National Yoga Referees of Yoga Federation of India attended the championship.

West Bengal Yoga Team won the Overall General Championship followed by Haryana State Yoga Team winning 1st Runner's up position and Maharashtra Yoga Team winning 2nd Runner's up position.

A Mass Yogasana Demonstration of all the players participating in the 48th Senior National Yoga Sports Championship was presented during prize distribution function on 23rd March, 2024.

Also the federation is indebted to the management of H.M. Education Centre, Hindmotor, Hooghly (West Bengal) for sparing their beautiful premises and providing other facilities for the successful organization of 48th Senior National Yoga Sports Championship.

The Yoga Federation of India conveys its gratitude to all the office bearers of Yoga Federation of India, Presidents & General Secretaries, State / UT Yoga Associations, All the National Yoga Referees of Yoga Federation of India, Technical Team, coaches, Yoga Players & their parents for their whole hearted participation, support and co-operation to make all these activities of Yoga Federation of India possible.

The house appreciated the activities of Yoga Federation of India during the session 2023-24 and unanimously approved the same.

3. Approval of Audited Income & Expenditure Statement of Accounts for the session 2023-24 : -

Shri Raman Kumar, Treasurer, YFI presented the Audited Income Expenditure Statement of Accounts for the session 2023-24.

Adv. B. Balachandran, Vice President, YFI, President, Yoga Association of Kerala and Shri M.P. Singh, President, Yoga Sports Association Madhya Pradesh proposed, Shri Prabhat Ch. Bora, Joint Secretary, YFI & General Secretary, Assam Yoga Association seconded and the house unanimously passed the audited Income & Expenditure Statement of Accounts for the session 2023-24.

4. Allotment of 49th Senior National Yoga Sports Championship and 50th Sub-Junior & Junior National Yoga Sports Championship and 50th Senior National Yoga Sports Championship : -

The president, YFI informed that the for the organization of 49th Senior National Yoga Sports Championship the offer has come from two state organizations i.e. Yoga Sports Association of Rajasthan and Yoga Association of Kerala. After deliberation the house unanimously agreed to allot the 49th Senior National Yoga Sports Championship to Yoga

Association of Kerala to be organized tentatively in the last week of January or first week of February, 2025.

Adv. B. Balachandran, President, Yoga Association of Kerala conveyed his thanks to the members present in the meeting and informed the house that the final dates will be informed earlier possible.

Regarding organization of 50th Sub-Junior & Junior National Yoga Sports Championship and 50th Senior National Yoga Sports Championship, the names of Yoga Sport Association of Rajasthan and Karnataka State Amateur Yoga Sports Association were considered. The official from Bihar Yoga Association also gave his consent to organize any of the National Yoga Events in Bihar in the near future.

5. Organization of 9th Federation Yoga Sports Cup-2025 : –

Regarding organization of 9th Federation Yoga Sports Cup-2025, the President, YFI informed the house that if any of the State/UT Yoga Association is interested to conduct it, offline then they can offer their request, otherwise it will be held online most likely in the month of May/June, 2025.

6. Any other point to be discussed with the permission of chair.

Shri Ashok Dutta, representative of President, West Bengal Yoga Association wanted to enquire about the present status of court proceeding of YFI case, on which the President, YFI informed that an application dated 21.10.2024 was filed by Yoga Federation of India seeking early hearing of the case which was heard on 23.10.2024 to which Hon'ble Justice directed the respondents to submit written submissions to Hon'ble court at least two weeks before the next date of hearing i.e. 10th January, 2025 for final hearing.

Further it was requested by Shri Ashok Dutta that the age groups of National Yoga Sports Competitions should be reduced, on which the President, YFI informed that the present age group have been made so as to give maximum opportunity to the participants to participate in their respective age groups.

It was proposed by President, YFI in that the amount to be contributed by YFI to the host state for organization of National Yoga Sports Championship may be increased from Rs. 2,00,000/- to Rs. 2,50,000/- w.e.f. current 49th Sub-Junior & Junior National Yoga Sports Championship at Una (Himachal Pradesh) which was unanimously appreciated as well as approved by the members present in the house.

The President, YFI informed that as per earlier decisions, the State Yoga Associations must conduct their State Yoga Sports Championship annually and inform the federation regarding the dates of their State Yoga Sports Championships, so that an observer from nearby State can be deputed by the federation, whose second class railway fare will be borne by the host State Yoga Association. The observer will send the report to the federation after conclusion of the State Yoga Sports Championship.

The President, YFI informed the house that some of the senior and experienced members of Yoga Federation of India, who cannot hold the office of YFI after attaining the age of 70 years or otherwise, as per Ministry of Sports, GOI guidelines may be associated as Advisory Board of Directors in the Yoga Federation of India.






